In response to federal regulations, the University of Miami (UM) requires Restricted Party Screening (RPS) conducted on persons and entities before engaging in any business transaction. The UM Center for Computational Science (CCS) - RPS "EXPORT-S-009_CCS form; is to furnish guidance with a tailored approach for RPS procedures for the foreign persons and entities that will be utilizing the Supercomputer services. CCS RPS method will focus on a risks matrix analysis process to determine - Low - Moderate - High risks entities, governments, entities and individuals screened for the CCS services rendered. The CCS RPS is done *prior to engaging in business activities* to confirm that the person or entity does not appear on any agency list of denied or excluded parties.

INSTRUCTIONS:

- Please be sure to type in the field "Individual Name" as it appears on his/her passport or driver license. Do not use titles, abbreviations, or nick names. (e.g., Dr., Mr., Ph.D., MD)
- If you are not certain how to answer a question, please do not check "no". Instead, please contact the Export Control Compliance office at: <u>exportcontrol@miami.edu</u>.
- The form is to be returned to the Export Control Compliance office mailbox of the person or entity to be screened in the subject line. You may copy on the "Cc" any relevant persons except the person or entity being screened as this is an internal process not to be shared. (see example below)
